House again in Committee to consider of altering Schedule A of same Acts, 216. Resolution respecting alterations in Schedule B reported, 228. Read second time; Amended by adding words "This Resolution shall take effect on and after 20th April, 1883; Resolution agreed to as amended, 230. Resolutions respecting alterations in Schedule A, reported, 230. First resolution amended by making alterations in duties on articles mentioned in certain items, take effect on certain day; Resolution, as amended agreed to; Second resolution agreed to, 234. House again in Committee; Resolutions granting certain sums out of the Consolidated Revenue Fund towards making good the Supply granted to Her Majesty; Reported; Agreed to; Bill presented, 434.
