THE House met pursuant to adjournment.—PRAYERS.

Read a third time, as engrossed, the Bill intituled "An Act for the more effectual recovery of sums subscribed towards the Support of Clergymen and School Masters; and towards erecting and repairing Churches, Chapels, Meeting Houses, and School Houses."

Ordered, that the said bill do pass.

Mr. Montgomery moved for leave to present a Petition from the Presbyterians, Methodists, and Baptists of Richmond Bay, for a share in the Glebe Lands. Leave being granted, the said Petition was read, and ordered to be referred to the Select Committee appointed to report on Petitions relating to Glebe Lands.

On motion, the House resolved itself into a Committee of the whole House, on the consideration of the Bill intituled "An act to authorise the conviction and punishment, in a Summary Way, of persons committing common Assaults and Batteries."
