It is claimed that a quarter of an ounce of freezone will cost very liftle at any of the drug stores, but is sufficient to rid one's feet ed every hard or soft corn or callus. You are further warned that cutting at a corn is a suicidal habt. THE sole head of a family, or any male over 18 years old may home stead a quarter-section of available Dominion land in Manitoba, Saskat-chewan or Alberta. Applicant must appear in person at the Dominion Lands Agency or Sub-Agency for the District. Entry by proxy may be made at any Dominion Lands Agency (but not Sub-Agency), on certain conditions.

Duties-Six months residence upon and cultivation of the land in each of and cultivation of the land in each of three years. A homesteader may live within nine miles of his homestead on a farm of at least 80 acres on certain conditions. A habitable house is required 'except where residence is performed in the vicinity. Live stock may be substituted for cultivation under certain conditions.
