As the Prime Minister said on May 7, we are issuing invitations to a number of nations with experience in this field to attend an exploratory conference in Canada within the next few months. We are following up with detailed suggestions as to the pattern which such a joint examination of this ou problem might follow. Out of it we hope to obtain not only improved methods by which those nations can prepare themselves for peace-keeping service under v the United Nations but some concrete conclusions which could be made available to other interested states and which would perhaps encourage them to set up stand-by units within their national forces.

Speaking of the United Nations, I know I can say for all members of this House that we are looking forward to the visit on Monday and Tuesday next of the United Nations Secretary-General, U Thant, who will address the combined Houses of Parliament in this Chamber on Tuesday morning. He will find us a nation dedicated to the Charter of the United Nations, as has once again been demonstrated by Canada's contribution to the difficult peace-keepin pan operation on the island of Cyprus.

Cyprus: Its Meaning for NATO
