- 2. How many of these have been subsequently discharged as unfit.
- 3. How many of these were discharged in Canada, and how many overseas.

On motion of Mr. Steele, seconded by Mr. Stevens,

Ordered, That there be laid before this House, a Return showing:-

- 1. How many applicants for enlistment in the Canadian Overseas Forces have been rejected on account of being physically unfit.
 - 2. How many have been discharged after enlistment for the same reason.

On motion of Mr. Carvell, seconded by Mr. Kyte,

Ordered, That there be laid before this House, a Return showing:-

1. Whether any changes were made in the Ross Rifles Mark III, in England.

2. What changes were made, and when were they made.

3. Who gave the instructions for any changes made.

- 4. Whether they were carried out under the supervision of the Militia Department by duly qualified experts.
- 5. Whether the rifles, as changed, were duly proven according to War Office regulations, before they were given back to the Canadian troops.

On motion of Mr. Turriff, seconded by Mr. Sinclair,

Ordered, That there be laid before this House, a Return showing:-

1. The date of the last order given by the Government to the Ross Rifle Company.

2. The number of rifles ordered.

- 3. Whether a recommendation of the British Army Council for the utilization of existing Canadian facilities in manufacturing the new and improved Lee-Enfield was received by the Government.
 - 4. The date of the recommendation, and when it was received.
 - 5. Whether the recommendation has been acted upon.

On motion of Mr. Cruise, seconded by Mr. Devlin,

Ordered, That there be laid before this House, a Return showing:-

1. The total number of Ross Rifles made by order of the Government of Canada to date.

2. The cost per rifle.

3. The number of these rifles in the hands of Canadian soldiers in France.

4. Whether these rifles are still being made.

- 5. If they are not being made to the Government order, at what date did the making cease.
- 6. The disposition made of the Ross Rifles taken from the Canadian Forces in France when they were re-armed with Lee-Enfields.
- 7. Whether the Government has any information as to whether the Ross Rifle Company is now making Lee-Enfield Rifles for the British Government.
- 8. Whether the Government will lay on the Table the report of the Military Commission of inquiry regarding the Ross Rifle, which sat in England, in the year 1915.

On motion of Mr. Wilson (Laval), seconded by Mr. Fortier,

Ordered, That there be laid before this House, a Return showing:-

- 1. Whether the Government can inform the House as to what was, on the 1st December, 1916, the quantity of butter, cheese, eggs, fowl, turkeys in the cold storage buildings of the Dominion, particularly in the City of Montreal.
 - 2. The value of these goods.
