Motion No. 98-Mr. Orlikow:

If one House desires any return relating to the business or proceedings of the other, neither courtesy nor custom allows such a return to be ordered; but an arrangement is generally made, by which the return is moved for in the other House; and after it has been presented, a message is sent to request that it may be communicated.

At page 282 of Bourinot's fourth edition, there are words to the same effect. There are also words to the same effect at pages 271 and 272 of May's 17th edition. That passage refers to the courtesy and custom in this regard. I ask the hon. member for Winnipeg North Centre, on behalf of the hon. member for Winnipeg North, to agree to withdrawing motions numbered 98, 99 and 148 and I will undertake to have the Government Leader of the other place present the appropriate motions in the other place so that the information will be forthcoming.
