EL SALVADOR—CALL FOR DIPLOMATIC EFFORTS TO STOP FLOW OF ARMS—MOTION UNDER S.O. 43

**Mr. Walter McLean (Waterloo):** Madam Speaker, I rise on a matter of urgent concern which I hope will receive the unanimous agreement of the House. In the light of reports of over 600 persons killed in the last five days in fighting in El Salvador and of 9,000 deaths due to political violence in 1980, and in light of Canada's support for the United Nations resolution of December condemning military aid to El Salvador, followed by the present visit of the Prime Minister (Mr. Trudeau) to Mexico City and the recent visit of the Secretary of State (Mr. Fox) and other ministers to Mexico, signifying Canada's interest in Central America's concern, I move, seconded by the hon. member for Edmonton South (Mr. Roche):

That this House urge the government to increase its diplomatic efforts to stop the flow of arms to El Salvador, and that the Secretary of State for External Affairs be encouraged to meet with the seven-man diplomatic mission of the revolutionary democratic front in Ottawa next week.
