

Adjustment of Accounts Act

Some hon. Members: Agreed.

Clause 32 as amended agreed to.

Mr. Daudlin: Following on that amendment, I move:

That Bill C-22 be amended by renumbering clauses 32 and 33 as clauses 33 and 34 respectively.

The Deputy Chairman: Shall the amendment carry?

Some hon. Members: Agreed.

Amendment agreed to.

Clause 33 agreed to.

On clause 34—

Mr. Clarke: Mr. Chairman, again I should like to call on the President of the Treasury Board to explain the need for the various dates of coming into force of the act.

Mr. Johnston: Mr. Chairman, the write-offs which we have discussed will be effective as of March 31, 1981, but the revolving funds which are provided for come into effect as of April 1, 1980. That accounts for the difference in dates with respect to the coming into force of the various provisions of the bill.

The Deputy Chairman: Shall clause 34 carry?

Some hon. Members: Agreed.

Clause 34 agreed to.

Schedule I agreed to.

On schedule II—

Mr. Daudlin: Mr. Chairman, I move:

That Bill C-22 be amended in item 3 of schedule II in column II thereof on page 24 by adding, immediately after "L26a Energy, Mines and Resources No. 3, 1978-79 Schedule", the following:

"L42a Energy, Mines and Resources No. 1, 1980-81 D".

Also I have a second amendment to schedule II that I would like to put. I move:

That Bill C-22 be amended in item 9 of schedule II in column II thereof on page 25 by adding, immediately after "L31b Transport No. 4, 1974 Schedule", the following:

"L66a Transport No. 1, 1980-81 D."

These two amendments are required in order that votes which were included in supplementary estimates but were not approved until May 16 could be included inasmuch as this bill was introduced at a later date.

Amendments (Mr. Daudlin) agreed to.

The Deputy Chairman: Shall schedule II as amended carry?

Some hon. Members: Agreed.

Schedule II as amended agreed to.

Schedules III to VI inclusive agreed to.

The Deputy Chairman: Shall clause 1 carry?

On clause 1—

Mr. Knowles: Mr. Chairman, I rise for only a minute before we conclude committee consideration of this bill. I noticed with interest that the hon. member for York North at second reading stage took the occasion of this bill to indulge in a bit of CBC bashing, which is something that happens around here from time to time. I do not intend to take his attack so seriously that I would launch into a full dress speech, but I should like to give one example to make the point that the CBC is not always bad.

A few weeks ago the House gave unanimous endorsement to a motion that I sought to move under Standing Order 43 which asked the CBC to make a certain change in its nightly news broadcast over television. I suggested that we from the west found it a bit awkward that the section "Across Canada" always started from the east and worked across to the west, and I suggested that the House ask the CBC to vary that, once in awhile, by starting from the west, sometimes from the prairies and sometimes from the north. I rise to remind hon. members, and I am sure they have all seen it, that one of the things we enjoy every night now is wondering where the "Across Canada" segment will start. In other words, at least on this occasion the CBC did pay attention to a constructive and respectful suggestion which was made by this House.
