**Mr. David Smith (Parliamentary Secretary to President of the Privy Council):** Madam Speaker, the following questions will be answered today: Nos. 3,306, 3,307, 3,551, 4,105, and 4,230.

MR. JAMES A. WINDSOR

Question No. 3,306—**Mr. Cossitt:**

1. Was Mr. James A. Windsor of Prescott, Ontario a term Immigration Officer at Prescott, Ontario from May 25 to August 24, 1981 and did he file for a competition to become a permanent employee?

2. Was Mr. Windsor advised that he would be interviewed on October 13, 1981 and was he telephoned on October 9, 1981 from Cornwall, Ontario to confirm whether he would still be able to make the interview?

3. Did he receive a letter dated October 2, 1981 and signed by Mr. Fern LeBrun, Manager of the Department of Employment and Immigration Centre in Cornwall, Ontario setting up an interview on October 13, 1981 at 2 p.m. and was this interview cancelled minutes before it was to take place and, if so, for what reason was Mr. Windsor treated in this fashion?

4. Was he discriminated against in any way whatsoever?

5. What were the names and job designations of all persons involved in any attempt to stop him from being interviewed?

6. Did (a) Mrs. Bonnie Trotman (b) Mr. J.R. Gaudet of the Department of Employment and Immigration in Prescott, Ontario play any part in this matter and, if so, what part?

**Hon. Lloyd Axworthy (Minister of Employment and Immigration):** 1. to 6. Mr. James A. Windsor was a term CR-5 employee at the Prescott Canada Immigration Centre (Immigration Examining Officer Assistant) from May 25, 1981 until August 24, 1981. All other parts of the question request information of a personal nature concerning Mr. James A. Windsor, the disclosure of which is governed by the Canadian Human Rights Act, Part IV.
