RAOUL WALLENBERG HONORARY CITIZENSHIP ACT

MEASURE TO ENACT

Mr. Roland de Corneille (Eglinton-Lawrence) moved for leave to introduce Bill C-233 to proclaim Raoul Wallenberg an honorary citizen of Canada, and requesting his return to freedom.

Mr. Speaker: Shall the Hon. Member have leave to introduce the said Bill?

Some Hon. Members: Agreed.

Mr. de Corneille: Today I have the honour and privilege to introduce a Bill to make Raoul Wallenberg an honorary citizen of Canada. It is a Bill which doubtless is of special interest to the Speaker himself. This Bill is intended as a one-time unique response and is not intended to set a precedent.

During World War II in Budapest, Hungary, this Swedish diplomat, at great risk to his life, saved tens of thousands of Jews who otherwise would have gone to the gas chambers of Auschwitz, by making these people honorary citizens of Sweden.

In a non-partisan and unified effort, we can do for him what he did for others and try to save his life by making him an honorary citizen of Canada. This will give him the opportunity to impress upon his—
