

The Order being read for the second reading of Bill No. 393 (Letter Y-13 of the Senate), intituled: "An Act for the relief of Barbara Fay Howard Goulet";

Mr. Henderson, seconded by Mr. Brown (Essex West), moved,—That the said Bill be now read the second time.

After debate thereon; the question being put on the said motion, it was agreed to, on division.
