- 10. (a) What is the Department's estimate on the volume of dioxin used in the US over the past five years (b) has the volume increased or decreased during this period (c) what was the volume used last year?
- 11. (a) Are there any prohibitions on the use of products which contain the contaminant dioxin near residences (b) are there any other prohibitions on the use of these products?
- 12. Are there any alternative products which do not contain dioxin and could be used as effectively as those products which do contain this contaminant and, if not, is there any research currently underway on alternative products?
- 13. Is there any evidence of birth defects, still births or serious illness, in Canada or the US, associated with the spraying of herbicides which contain the contaminant dioxin and, if so, what are the details?
- 14. Do any government departments use products which contain dioxin and, if so (a) which departments (b) in what quantities (c) are permits required for the use of these products?
- 15. Has the government considered banning products which contain dioxin and, if not, for what reason?
