The Chairman reported that the Committee had made some progress therein, and recommended that a Committee of Conference be appointed to meet a Committee of the Commons' House of Assembly, on the subject matter thereof.

On motion made and seconded, the Honorable Messrs. Clark, Markland, and Allan, were appointed a Committee for that purpose.

A Message, in the following words, was, by the Master in Chancery, carried down and delivered to the Commons' House of Assembly:—

Mr. SPEAKER,

Message to Assembly on the Navigation of the River Saint Lawrence

The Honorable the Legislative Council have appointed a Committee of three Members to meet a Committee of the House of Assembly, in the Joint Committee Room, to-morrow at twelve o'clock, to take into consideration the expediency of attempting immediately the improvement of the Navigation of the Saint Lawrence, on a scale that will admit of Steam-boats and Schooners, or whether it shall be confined to Boat Navigation.
