Which being read, ordered that the same be received and referred to the Committee of Supply.

Mr. *Chipman*, from the Committee appointed to make provision by bill, to defray the expenses of the Members of the House of Assembly during their attendance in General Assembly, and to defray their travelling charges---reported that the Committee had attended to that duty, had prepared a bill for that purpose, and had directed him to report the same, under the title of a bill, "to provide for the services of the Speaker of the House of Assembly, and for defraying the expenses and travelling charges of the Members of the said House in General Assembly."

Which was read the first time.

Mr. *Smith*, pursuant to leave, brought in a bill, "to repeal an Act, intituled "An Act for the further increase of the Revenue of this Province," passed 25th March, 1820: And also "An Act, in addition to an Act, intituled "An Act for the further increase of the Revenue of this Province," passed 29th March, 1820.

Which was read the first time.

Mr. *Wetmore* moved for leave to bring in a bill, "for the preservation of the Red and Fallow Deer in this Province."

Leave granted.

Mr. *Chipman*, by leave, presented a Petition of the Mayor, Aldermen, and Commonalty, of the City of Saint John, praying for authority to levy a further sum not exceeding £500, on the inhabitants of the said City, for the purpose of building and finishing the Poor-House in the said City.

Which being read, ordered that the same be received and lie on the table.

Mr. *Chipman*, pursuant to leave, brought in a bill, "to authorize the Justices of the Peace for the City and County of Saint John, to levy a further assessment on the inhabitants of the said City, for the purpose of building and finishing a Poor-House in the said City."

Which was read the first and second time.

Mr. *Chipman*, pursuant to leave, presented a Petition of the Mayor, Aldermen, and Commonalty, of the City of Saint John, praying for aid for further extending the Breakwater, at Battery Point, in the said City.

Which being read, ordered that the same be received and referred to the Committee of Supply.

On motion of Mr. *McKay*, resolved that an humble Address be presented to His Excellency the *Lieutenant-Governor*, praying that he will be pleased to cause to be laid before the House, such documents or papers as he may deem necessary for the information of the House, relative to the operation of the Plaster Duty Acts, passed at the last Session of the General Assembly.

Ordered that Mr. *McKay*, Mr. *Clarke*, Mr. *Munro*, be a Committee to present the same.

A Message from the Council.

Mr. *Attorney-General* delivered the Message, as follows:

Ordered that Mr. *Chipman*, Mr. *Agnew*, inform the Council thereof.

The House adjourned till this evening at seven o'clock.
