

Of *Rowland Burr*, of the City of *Toronto*; alleging many advantages that would accrue to the Province by the construction of a Canal across the Peninsula of *Upper Canada*, to connect Lake *Ontario* with the *Georgian Bay*; and praying for certain amendments to the Act incorporating the *Georgian Bay Canal Company*,—and that he may be heard before a Select Committee of the House.

Of the Mayor, Aldermen, and Commonalty of the City of *Toronto*; praying for the passing of an Act to authorize them to erect new Water Works in the said City, and to borrow a sufficient sum of money, upon the credit of Debentures to be issued by them, to defray the cost of the same.

Of the Colonial Bank of *Canada*; praying for amendments to their Act of Incorporation.

Of *Robert Moodie* and others, Boatmen; praying that the Act for the protection of persons owning Lands on the shore of Lake *Ontario*, in the Counties of *York*, *Peel*, and *Halton*, may not become law.

Of the Sisters of *St. Ann*, of the Parish of *St. Jacques de L'Achigan*; praying aid to enable them to make certain necessary repairs to the Female Academy in the said Parish.

Of the Municipality of the Township of *Harwich*; praying that immediate steps be taken to rebuild the Light House at the *Rondeau Point*, in the said Township.

Of the Municipality of the Township of *Harwich*; praying for an Act of incorporation under the name of the International Bridge Company.

Of the Municipality of the Township of *Goderich*; and of the Municipality of the Township of *Osborne*; praying that the Townships of *Howick* and *Carrick* may not be included in the new County which is to be formed.

Of the Municipality of the Township of *Carrick*; praying that the said Township may not be included in the new County which is to be formed.

Of *Robert Gibson* and others, of *Grey*, and other Townships, County of *Huron*; praying that the Townships of *Grey*, *Howick*, *Turnberry*, *Culross*, *Carrick*, *Normanby*, *Minto*, *Wallace*, and *Elma*, may be formed into a new County.

Of *F. E. Juneau*, President, in behalf of the Library Association of Teachers of the District of *Quebec*; praying for aid.

Of *F. E. Juneau*, Principal of the Commercial and Literary Academy of *St. Roch's, Quebec*; praying for aid.

Of the Reverend *Edward Denroche*, Missionary at *Springfield* and *Sydenham*; praying for arrears of salary due him as said Missionary.

Of the Municipal Council of the County of *Chateauguay*; praying that *Russelltown*, and a part of *Jamestown*, may not be detached from the said County.

Of the Reverend *Hannibal Mulkins*; praying for arrears of Salary due him as a Missionary in the Township of *Pakenham*.

Of *G. Baptist* and others, of the Town of *Three Rivers*; alleging that they have formed a Joint Stock Company in accordance with the provisions of the Act 13 & 14 Vic. cap. 21; and praying that they may be exempted from the provisions of the Bill now before the House to discontinue the incorporation of Joint Stock Banks, and the issue of Registered Bank Notes under the Free Banking Acts.

Of *Joseph Robert* and others, Members of the Mechanics' Society of *St. Césaire*, County of *Rouville*; praying for aid in behalf of the said Society.

Of the Reverend *J. A. Provençal* and others, of the County of *Rouville*; praying for aid to repair the Plank Road leading from *Chambly* to *St. Césaire* and *Granby*.

Of the Municipality of the Parish of *St. Prosper*, County of *Champlain*; and of the Municipality of the Parish of *Ste. Geneviève de Batiscan*, County of *Champlain*; praying for the repeal of the *Lower Canada Municipal and Road Act of 1855*.
