Income Taxpayers Must Pay Up if They Want to Vote.

All those assessed solely for income, according to the Municipal Act, must have their income tax paid before they are entitled to vote at the municipal elections on Monday next. According to the Act the treasurer or collector (in this case the collector) is compelled. under a penalty of a \$400 fine, to furnish the returning officer with a list of all defaulters, that is to say to quote the section: "All persons who, being on the voters' list (that is to say the first and second parts thereof) in respect of their income only, have not paid their municipal taxes on such income on or before the 14th of December preceding the election." In respect of this list sec. 88 of the Act states: "No person who has been returned by the collector as in default for non-payment of his taxes shall be entitled to vote in respect of income, but any person who is entitled to vote, and who at the time of the tendering of his vote, produces and leaves with the deputy-returning officer a certificate from the collector of taxes, showing that the taxes in respect of which default had been made, have since been paid, shall be entitled to vote."

From the above sections it is evident that about forty defaulters in respect of income tax will be unable to vote on Monday unless they pay up their taxes before asking for a ballot.
