Mr. P. D. McCallum was not a political speaker, so he said, and had never up to that time appeared on a political platform. However, he had friends to talk for him. He said that he had bound himself to nothing, and had not left his name before the Reform convention until the last moment and then withdrawn it. It was true that he belonged to a society called the P. P. A., a thoroughly Protestant society, but not a society to boycott Roman Catholics. Noted English Murder Case. EDINBURGH, Dec. 25 .- Alfred J. Monson, who is indicted for the murder of Lieut Hambrough, was arraigned before the High

who is indicated for the introduction of Justice to day, to answer the charge against him. He pleaded not guilty and his trial was fixed for Dec. 12.

This case, popularly known as the Ardamont mystery, has created great interest overywhere in Great Britain. Mr. Monson was the prospective purchaser of the Ardamont estate and had engaged it for the shooting season as a temporary arrangement. He was joined at Ardamont House by his triend Lieut. Hambrough. On Aug. 10 last, the lieutenant's dead body was found on the grounds, and it was surmised he had tripped, his gun had exploded and the shot entered the head, causing death. Mr. Monson had been with him and an attendant, Scott, in the employ of Mr. Hambrough, just before the supposed accident, but the shot had entered the back of the head, and it was Monson's gun that had been used. Mr. Monson explained that he had exchanged guns with his friend.

Scott disappeared immediately after and has not since been heard of. The body was buried at Ventnor, in the Isle of Wight, where the Hambrough family reside. Peytral had handed in his resignation. This caused M. Pelletan's realization to exclaim in a loud tone: "Not having a united Cabinet before me I decline to speak."

Mr. Pelletan's remark caused the Left to break into renewed applause. M. Brisson

PHILADELPHIA, Nov. 26.—T. V. Powderly resigned his position of general master workman of the Knights of Labor yesterday atternoon. He was unable to keep the delegates in the line he had marked out and the decisive move seemed to be the only one left for him to adopt. Immediately after his resignation was offered he left the hall, as he said, to attend to some personal business. This step was a surprise to all the delegates, although a few of them said it was what he should have done long ago. No action was taken on the matter.

After Mr. Powderly had been repeatedly urged by the assembly to substitute a new list of names for members of the executive committee, he sequiesced in these demands. The second list was not much more tavorably received than the first one, but he was most persistent in his efforts to have it accepted. McGuire, of New York, was the only one elected, and the assembly adjoarned Friday without geating any turther along. Yesterday the fight was begun with new viger. Every point raised by the master workman was stubbornly fought by his opponents, and the anti-Powderly faction began to elect a board that would snit them. The first man chosen in this way was H. B.
