## PROTOCOL MODIFYING PART I AND ARTICLE XXIX OF THE GENERAL AGREEMENT ON TARIFFS AND TRADE\*

The Governments of the Commonwealth of Australia, the Kingdon Belgium, the United States of Brazil, Burma, Canada, Ceylon, the Republication of China and Ceylon, the Ceylon of Ceylon and Ceylo of China, the Republic of Cuba, the Czechoslovak Republic, the French Republic India, Lebanon, the Grand Duchy of Luxemburg, the Kingdom of the Netherlands No. 7 lands, New Zealand, the Kingdom of Norway, Pakistan, Southern Rhodes Syria, the Union of South Africa, the United Kingdom of Great Britain Northern Ireland, and the United States of America, acting in their capacitation of contracting parties to the General Agreement on Tariffs and Trade (here) after referred to as the Agreement),

Desiring to effect an amendment to the Agreement, pursuant to the property of Article Ways of Article Ways and Article Ways of visions of Article XXX thereof.

## HEREBY AGREE AS FOLLOWS:

1. The texts of Articles I, II and XXIX of the Agreement and certain related provisions in Annexes A and I shall be modified as follows:-

- (i) The phrase "paragraphs 1 and 2 of Article III" in paragraph 1 Article I shall read; "paragraphs 2 and 4 of Article III".
- (ii) The phrase "paragraph 3 of this Article" in paragraph 2 of Article shall read "paragraph 4 of Article" in paragraph 2 of Article shall read "paragraph 4 of this Article".
- (iii) Paragraph 3 of Article I shall be renumbered paragraph 4 of the Article and the following Article and the following paragraph shall be inserted as a new party graph 3 thereof:-
  - "3.
