RECESS TO WELCOME ROYAL CANADIAN REGIMENT

Right Hon. L. S. St. Laurent (Prime Minister): Mr. Speaker, on a question of privilege, it has been suggested to me, in view of the fact that the Royal Canadian Regiment is returning from Korea and is to be on parliament hill at half past eleven so that their honorary colonel may return their colours to them, that we might recess for half an hour. It is unusual, but I am sure we are all very appreciative of what the young men of Canada have done to carry out our part of the United Nations undertaking, and it might be regarded as a fitting tribute from the House of Commons to congratulate them on their return and to express our sympathy for those they have left behind them in Korean graves.

Mr. Speaker: Is it agreed?

Mr. Fournier (Hull): Before we suspend the sittings, Mr. Speaker, I should like to say that after the recess we will proceed with item No. 5 on the order paper, Bill No. 338, an act respecting co-operative credit associations. I understand that the provincial associations who wish to come under this measure would have to apply to the House of Commons for a private charter, and any lelay in presenting this legislation would delay their application for a private charter. did not announce this on Friday evening pecause I was not acquainted with the facts intil Saturday. If there are any serious objections, we shall have to put if off until omorrow. Perhaps we could proceed today with this bill.
