## CANADA FAIR EMPLOYMENT PRACTICES ACT

### AMENDMENT TO EXTEND APPLICATION TO CIVIL SERVICE

**Mr. Frank Howard (Skeena)** moved the second reading of Bill No. C-19 to amend the Canada Fair Employment Practices Act.

He said: The Canada Fair Employment Practices Act came into effect on July 1, 1953 and, in short, it provides that no employer shall discriminate in so far as the employment of employees or the terms or conditions of employment are concerned because of race, national origin, colour or religion. The act also prevents an employer from using the facilities of a hiring agency which discriminates on grounds of race, national origin, colour or religion, and it provides, further, that a trade union shall not discriminate against its members or prevent potential members from becoming members of that union, and that it shall not expel them from the union on grounds of race, national origin, colour or religion.
