Inquiries of the Ministry

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, would the Prime Minister be prepared to table that agreement?

Mr. Pearson: As I announced at the time the agreement was signed, there were military details in this exchange of notes which, in accordance with NATO practice and considerations of military security, could not be made public, as I am sure my right hon. friend will appreciate.

Mr. Diefenbaker: Is it not possible to produce excerpts from the agreement other than the actual sections which come within military security? Surely the Canadian people have a right to know something of the subterranean operations that have gone on.

Some hon. Members: Hear, hear.

Mr. Pearson: Mr. Speaker, when the press statement was issued all the information which it was possible to give was given, and the procedure which was followed was that which I am quite sure the right hon. gentleman would have followed in similar circumstances if he had brought to a conclusion the draft agreement which he was considering at the time.

Mr. Diefenbaker: Mr. Speaker, I still ask the right hon. gentleman whether this cannot be done. There was a tremendous reversal of opinion on his part in this connection.

Some hon. Members: Order.

Mr. Diefenbaker: Will he not consider tabling the sections of the agreement which do not contravene security? That is the simple question.

Mr. Pearson: Mr. Speaker, the right hon. gentleman of course knows, because he has followed the procedure himself in the past, that in an exchange of notes of this kind dealing with military matters, to take out of an agreement two or three paragraphs and make them public would not only be a breach of security but would be a quite improper constitutional procedure.

Mr. Pigeon: The Nobel prize answer.

Mr. Diefenbaker: Quite improper politically, possibly.
