I refer to the Winnipeg Tribune of October 24, where Mr. Roblin is reported in quotes as saying:

"The delegation provisions of the draft are exactly the same as under the Fulton formula. That is why those who say it was a put-up job are completely wrong."

Mr. Diefenbaker: And, Mr. Speaker, if the Prime Minister could have got way with that falsity he would have done so.
