SAFETY REGULATIONS FOR VESSELS BEING REPAIRED

Question No. 748-Mr. Douglas:

- 1. Who establishes safety regulations for vessels being repaired while in Canadian ports?
- 2. Who has jurisdiction for the enforcing of any such regulations?
- Mr. J. A. Byrne (Parliamentary Secretary to Minister of Transport): 1 and 2. Assuming that the question relates to regulations for the protection against accident of workers engaged in repairing ships in shipyards, there are no Federal regulations on this subject; it is presumed that there are provincial regulations in most provinces.

COST OF OPERATING ARMED FORCES CAMPS

Question No. 752-Mr. Sherman:

What is the annual cost of operating (a) Fort Osborne military barracks in Winnipeg (b) H.M.C.S. Chippawa in Winnipeg (c) Camp Shilo, Manitoba (d) R.C.A.F. Station, Gimli, Manitoba?

Hon. Paul Hellyer (Minister of National Defence): Annual estimated costs for 1965-66 are as follows: (a) \$3,020,000; (b) \$50,000; (c) \$3,214,000; (d) \$1,670,000.

These costs include housekeeping costs of the bases comprising civilian labour, com-

munications, construction and engineering maintenance, salaries of commissionaires and teachers for dependants, heating and cooking fuel and public utilities.

*HARBOUR DEEPENING, PORT COLBORNE, ONT.

Question No. 762-Mr. Tolmie:

- 1. Is the Department of Transport negotiating for the deepening of harbours in Port Colborne at Canada Cement Company Ltd., and Maple Leaf Mills Ltd.?
