INQUIRY AS TO LOAN FOR ARCTIC EXPLORATION WORK

On the orders of the day:

Mr. T. C. Douglas (Burnaby-Coquitlam): I wish to address a question to the Minister of Northern Affairs and National Resources. Has he received an application for a loan from a syndicate headed by J. C. Sproule and Associates Limited of Calgary for exploration work in the Canadian Arctic? I wonder whether the minister would be prepared, either now or later, to give the house a statement indicating the amount of money involved and the terms on which such a loan would be made. I am particularly interested in knowing whether the government would acquire some equity interest in the project by way of fixed net royalty should a loan be granted.

Mr. Speaker: Order. I doubt very much that this is a matter of real urgency or that the question should be allowed at this time, although the minister responsible for the matter raised by the hon. member may wish to indicate whether he proposes to make a statement on motions at some later date.

Hon. Arthur Laing (Minister of Northern Affairs and National Resources): That is so. We have not yet completed the draft regulations pertaining to this particular exploration grant. When we have done so I expect to make a statement in the house.

Mr. Douglas: Since this would be setting a precedent for other loans in the Canadian Arctic I would appreciate knowing whether the minister contemplates making a statement before the deal is completed or after the loan has been made.

Mr. Laing: I can assure the hon. member it would be before the loan is made.

UGANDA-INQUIRY AS TO SAFETY OF CANADIANS

On the orders of the day:

Mr. R. N. Thompson (Red Deer): My question is directed to the Secretary of State for External Affairs. It relates to Uganda where the situation has reached the point of civil war. Can the minister reassure us as to the safety of Canadians there, and does he have any further comments to make on the situation?

Hon. Paul Martin (Secretary of State for External Affairs): As the hon, member knows, there has been a serious disturbance in Uganda. The situation there has, however, been fully covered by the news media in this country. I cannot add anything at this stage to what has already been reported. There are some 300 Canadians in Uganda. I have no reason to believe that their safety is in any way prejudiced at the moment as a result of this situation. We are following events closely.
