### MONTREAL-THEFT OF MAIL BAGS

Mr. Heath Macquarrie (Hillsborough): Mr. Speaker, may I direct a question to a minister whose words never outrun his thoughts, the Postmaster General. Has he anything to report on the investigation into yesterday's theft of mail bags in Montreal. Also, is he taking steps to protect valuable consignments on passage through the mail?

Hon. Eric W. Kierans (Postmaster General): Yes, Mr. Speaker. I can report that an investigation is being conducted by three different forces, postal investigators, the Montreal police and the provincial police. May I say that the amount in question was exaggerated. Although it is a very large amount it is, according to our best information, somewhat less than \$200,000.

#### REFUNDS ON BOX RENTALS

Mr. Mac T. McCutcheon (Lambton-Kent): A supplementary question, Mr. Speaker. Can the Postmaster General announce any plans to refund extra payments made by the holders of many post office boxes in cases where those box holders have responded to post office demands this year for extra payment—in other words, where double payments have been made.

Hon. Eric W. Kierans (Postmaster General): Yes, Mr. Speaker. Orders have already gone out to the effect that increased amounts of money demanded of people who had signed
