SURVEILLANCE OF ATLANTIC COAST—STATIONING OF TRACKER AIRCRAFT AND NAVAL VESSELS AT ARGENTIA

Mr. Walter C. Carter (St. John's West): Mr. Speaker, my question is directed to the Minister of National Defence. In view of the white paper recommendation for increased surveillance along the Canadian coastlines, is it the government's intention to station Tracker aircraft and naval vessels at the Argentia naval base in Newfoundland?

Hon. Donald S. Macdonald (Minister of National Defence): Not at the present time, Mr. Speaker. The Tracker aircraft squadron will be kept in operation, as the hon. member knows, at Shearwater. It can be understood that, as they have been this summer, they will be operating on occasion out of Goose Bay. We have no immediate intention to operate from Argentia.

Hon. Otto E. Lang (Minister of Manpower and Immigration): Mr. Speaker, the main role of the Canadian Wheat Board is based upon the control of grain as it passes across provincial boundaries. There certainly is no thought of destroying the Canadian Wheat Board by removing this role at this time.
