CONSTRUCTION OF NORTHERN GAS PIPELINE

Question No. 1,274—**Mr. Rowland:**

1. Has the government received representations from Mr. Charles P. Bennett and M. Dimentberg of Winnipeg, Manitoba, to the effect that the costs of construction of a Northern gas pipeline could be reduced by a factor of 50% if the system was designed to transport natural gas in a liquid rather than vapour state?

2. Has the government investigated the accuracy of the submission and, if so, by whom was the investigation carried out and what were the findings?

3. Has the government investigated the proposal for a liquid natural gas pipeline from the point of view of its potential for reducing damages which might result from a break and, if so, by whom and with what results?
