**Mr. Scott (Hamilton-Wentworth):** Madam Speaker, I am wondering when I may receive a reply to question No. 4,229 which was placed on the Order Paper a good six weeks ago at the invitation and urging of the Minister of Consumer and Corporate Affairs. He could not answer my question in the House and suggested I place it on the Order Paper. It is not a terribly difficult or complex question to answer, but it is very timely in view of the number of young people looking for summer employment. The question deals directly with the criteria this government used to man the Metric Commission information kiosks, and I would appreciate an answer as soon as possible.

**Mr. Smith:** Madam Speaker, I do not know the answer offhand but I will be pleased to look into this matter on the hon. member's behalf.

**Mr. Young:** Madam Speaker, can the parliamentary secretary indicate when we can expect an answer to question No. 4,165 concerning a number of related questions with respect to the Main Square apartment buildings in the city of Toronto?

**Mr. Smith:** Madam Speaker, I am not aware of what stage the answer to that question is at the moment, but I will be happy to look into it on behalf of the hon. member.

**Madam Speaker:** The questions enumerated by the parliamentary secretary have been answered. Shall the remaining questions be allowed to stand?
