broken its promise by reducing the family allowance through deindexation, and they request this Parliament to ensure that the Government will restore full indexation of the family allowance and also cancel its plans for other taxes that hurt low-income people.

PARITY PRICES FOR AGRICULTURAL PRODUCTS

Mr. Steven W. Langdon (Essex-Windsor): Mr. Speaker, I have the pleasure to present a petition signed by more than 1,000 people. They stress, first, the urgency of the farm crisis, the great financial squeeze affecting many farmers, and they argue for hearings across this country on the principle of parity pricing through the Standing Committee on Agriculture.

This is signed by people from right across Essex county, as well as from the following towns and communities across Ontario: Simcoe, Lucknow, Wingham, Mount Hope, Durham, Goderich, Kincardine, Chatham, Brantford, Forest, New Liskeard, Thedford, Cayuga, Chesley, Port Elgin, Arkona, Blenheim, parts of Middlesex County, Ailsa Craig, Petrolia, Wiarton and Owen Sound. They all stress the urgency of this crisis which requires a response.

EFFECTS OF U.S. LEGISLATION ON FOREST INDUSTRY

Mr. John Parry (Kenora-Rainy River): Mr. Speaker, I have the privilege to present a petition signed by a large proportion of the residents of Hudson and Sioux Lookout, Ontario, in my riding. These communities are heavily dependent upon the forest industry. They call upon the Government to get going and take some action to dissuade the United States Congress from passing into law the Gibbon's natural resources subsidy Bill which would indeed cost thousands of jobs in Canada's great forest industry.
