### PETITIONS

REQUEST FOR APPOINTMENT OF ARBITRATOR—SETTLEMENT  
WITH FRED TURNER

**Mr. Les Benjamin (Regina West):** Mr. Speaker, I have the duty and honour to present a petition from citizens in Ottawa and district. They state that Turnair of Yellowknife, Northwest Territories, whose representative appeared as a witness for the CTC, had its operating authority cancelled by the CTC after appearing before it, forcing Fred Turner, its operator, into bankruptcy. The cancellation of his licence is what bankrupted him.

Whereas the Queen's Privy Council of Canada later returned his operating authority and offered \$15,000 in compensation but did not consult or negotiate with him, the petitioners humbly pray and call upon the House that an independent arbitrator be assigned to this matter to investigate the details of the case and to review and to negotiate the offer from the federal Government with Fred Turner in order to reach an equitable settlement which better reflects the true nature of his loss. For this the petitioners and this Hon. Member humbly pray.

REQUEST FOR CHANGES TO ROAD SAFETY REGULATIONS

**Mrs. Thérèse Killens (Saint-Michel—Ahuntsic):** Mr. Speaker, I have the honour to present a petition signed by residents of Trois-Rivières and Halifax who are calling upon Parliament to amend the existing highway safety regulations. The petitioners believe that the rear seat-belts in passenger cars are presently inadequate and that the suffering of car-crash victims could be reduced or avoided.

They also believe that the cost of medical care for car-crash victims can be reduced or eliminated.

For all these reasons, the petitioners urge Parliament to institute mandatory installation of three-point adjustable lap-
