

TOTAL LIVE STOCK RUN WAS HEAVY

City Decreases 183 Cars,
Union Increases 160 Cars,
Compared With Same
Week 1911.

The total receipts of live stock at the City and Union Stock Yards for the past week were as follows:

The combined receipts of live stock at the two yards for the past week show a decrease of 22 cars, 480 cattle, 805 hogs, but an increase of 31 sheep, 322 calves and 10 horses, compared with the corresponding week of 1911.

At the City Yards the above figures show a decrease of 183 cars, 238 cattle, 135 hogs, 258 sheep and 33 calves, but an increase of 10 horses, compared with the corresponding week of 1911.

At the Union Yards the above figures show an increase of 160 cars, 206 cattle, 135 hogs, 263 sheep and lambs, 49 calves and 6 horses, in comparison with the corresponding week of 1911.

UNION STOCK YARDS.

Receipts of live stock at the Union Yards Friday were 12 cars, 419 cattle, 618 hogs, 421 sheep and lambs, 60 calves and 3 horses. There was a fair trade in steady prices in the different classes.

The cattle on sale were only fair to medium. Dealers stated that they need more good steers for butchery purposes, and are prepared to pay 10 to 15¢ more for those weighing 1200 to 1250 lbs.

The Swift Canadian Company bought 50 carloads of live cattle, at \$4.50 to \$5.00, 100 lambs at \$3.25.

There were 483 hogs on the market, which sold at \$10.00 to \$10.50, fed and watered.
