

Dr. Pringle's Message To Women of St. John

Delivers Inspiring Address Before Women's Canadian Club -- The Dangers of Bridge Whist -- Women and Public Affairs--Gives Hearers a Glimpse of Greatness of Dominion.

Before the Women's Canadian Club yesterday afternoon Rev. John Pringle of Sydney, C. B., gave an interesting and instructive address on the greatness of Canada, describing the vast territory to the north of the Saskatchewan and giving his hearers a glimpse of the Yukon. Referring to the talk of Dreadnoughts and war he emphasized that fact that while he had nothing to say against militarism, he believed it was wrong for Canadians to go about with a chip on their shoulders. The foundations of the country he said should be laid on righteousness. Mrs. E. A. Smith presided at the meeting and briefly introduced the speaker. There was a large attendance.

Dangers of Bridge Whist.

He was also glad to see the women of Canada taking an interest in public affairs and learning of the great possibilities of its future. He had never felt it his duty to keep away from functions at which bridge whist was played. There were however, in the more important affairs of life. But the Women's Canadian Club was dealing with more important affairs, and he believed if they were to take up the study of the history of Manitoba or Quebec during the winter they would find it quite as enthralling as bridge. Douglas Old France in the New World, and Robert Seller's, The Tragedy of Quebec, were interesting books that could be profitably studied.

Talk Of War Unworthy Of The People.

In conclusion, Dr. Pringle said he had tried to give his hearers a glimpse of the greatness of Canada, but it would never be great unless his hearers were great. He had nothing to say against militarism, his father was a soldier, but the talk about Dreadnoughts and war, was unworthy of the people. It was good for a boy to be able to protect himself with his hands, but it was wrong for him to go about with a chip on his shoulder, and that was what the Canadians were doing.

He believed there should be thorough military training in all our schools, and the boys taught to shoot straight. But the foundation of the country should be laid on righteousness.

KING ALFONSO REGRETS FERRER DEMONSTRATIONS

Deplores Outbreaks in France -- Not Savages As Some Frenchmen Think, He Declares.

Paris, Nov. 3.—A special despatch from Madrid to the Journal gives an interview with King Alfonso, who expressed himself bitterly on the Ferrer demonstrations abroad. He said he understood the attitude of the masses, who were always ready to take sides with what they considered right, but he continued, "Intellectual savants, who do not dare to announce a discovery before it is verified, a hundred times by experiments, should protest without inquiry against a judgment conformable with laws they are ignorant of and against the guaranteed honor of Spanish soldiers, I cannot understand. To listen to certain Frenchmen one would think we were savages and live in a time of the Inquisition, instead of a constitutional monarchy, so constitutional indeed that I have not even the initiative of the right of pardon."

MRS. STEVENS' Age Has No Terrors For Lily Langtry

COMPLETE AND FULL RETREAT

Declares That She Is No Rebel and Announces That She is Obedient to Mrs. Eddy and the Constituted Authorities.

New York, N. Y., Nov. 3.—Mrs. Augusta E. Stetson, of the First Church of Christ, Scientist, sends this to the press of the United States and Canada: "The reports that I am resisting the authority of the board of directors of the mother church and that I expect to secede from that church and form an independent church are false. I have not said to any one any of the things attributed to me in the papers. On October 16, 1909, I notified the directors of the mother church that I would comply strictly with their orders and therefore would neither teach classes in Christian Science nor convene nor attend my students' association. I leave all judgment to God, the righteous Judge. On the same day I notified the trustees of the First Church of Christ, Scientist, New York city, that I had so advised the authorities of the mother church. I also requested the secretary of my students' association to notify its members whom I taught in past years that there would be no meeting of my students this year.

Never Secede.

"I shall never secede from Christian Science, and no student of mine with my approval will ever secede from Christian Science or disobey the constitutional authorities of our denomination. I was never more devoted to the cause of Christian Science and to which I have given my whole life for 25 years. I was never more grateful, loving and obedient to my revered leader, Mary Baker Eddy, discoverer and founder of Christian Science, and the leader forever of all true Christian Scientists.
