

2nd WITNESS FOR THE PROSECUTION

B 49602 Sgt SANDERSON, C.F.I., RCAMC, on strength No 1 CGMU having been duly sworn states:

I am employed in the First Aid Post, 1 CGMU. I know Pte Anderson, he is the accused sitting there. I was in the FAP on the 6 Oct 44 when the accused came in and was ordered by Capt Rose to submit to an inoculation to which he refused. Capt Rose told him that he was ordering him to take the inoculation, the accused said he did not feel that he needed it and would not accept it. Capt Rose then put him under open arrest.

CROSS EXAMINATION BY THE DEF OFFR

Q Will you explain the method which is used when these men come into the FAP for inoculations?  
A They come in for mad inspections either on incoming drafts or outgoing, in this case it was an incoming one. Their book is handed to a clerk who checks it for vaccinations and inoculations if the man requires a shot he is sent in to the MQ, an entry is made in the Pt I of the pay book and sent in of all the men who need the shot.

Q On this date how many men were inoculated at the one time?  
A I cannot say exactly but there was about 15 I would say. Their pay books were checked and those who needed the shot were told and they lined up, then go into the MQ one after the other and come out another room and receive their paybooks with the entries all made up and signed.

In the opinion of the Court it is unnecessary to comply with RF 83(B)

RESPONSE TO THE PROSECUTOR

Is this all the evidence you have to produce?

PROSECUTOR:

Yes Sir, the other MQ, Capt Heagy, was not on duty on the 5 Oct. There was another M.O., Capt Roy who was on strength of 1 RMTD at this time who worked in the RAF at different times but he is now not available to give evidence.

The Accused (B 116423 Pte ANDERSON, D. St Clair) on strength No 1 CGMU having been duly sworn states:

On 5 Oct 44 I was taken into the MIR on draft with several other men who were to leave that day, we were inspected for itch, crabs etc. After the inspection I was inoculated for typhus by another man in the next room to the one I was inspected in. I do not know who he was or what rank he had, I did not look at him, as I do not look when being inoculated I keep my eyes away from them and try to think of something else. After the inoculation I went out collected my pay book and went to leave the room, there were still men in line up the inspection and inoculations and there was a crowd in the room, I was pushing my way through when someone touched me on the arm and said "you have to see the MQ, I thought there was something wrong and wondered why they were calling me back. I was again inspected by some man and then given my clothes and told to go into the other room I entered here and they were going to give me the needle again, Capt Rose was there, I do not remember just what
