

RECORD FORM D—PROCEEDINGS ON PLEAS OF NOT GUILTY TO ALL CHARGES.

- D1. President to accused:** Do you wish to apply for an adjournment on the ground that any of the rules making to procedure before trial have not been complied with, and that you have been prejudiced thereby, or on the ground (i. e. if "yes," see *RP 29(A)*) for procedure. Statement or evidence, if any, is recorded per Notes ⁽¹⁾.
