TO BUILD A NEW ROAD

A Line Which the C. P. R. is Said to Be Contemplating.
FROM BUFFALO TO THE FALLS

Prospectus of the Work Which the Company is Said to Have in View—A Short Route, Commanding a Good View of the Falls of Niagara.

BUFFALO, Nov. 12.—For several years there has been more or less talk about the Canadian Pacific coming into Buffalo, but it has never developed into anything of a definite nature. However, the information that has recently come to this city is correct, and it came from a reliable source. The project is to build a line from Buffalo to the Falls of Niagara, and it is known as when it will do so.

Ever since the electric road from Chippewa to Queenstown was built and all doubt as to the Canadian Pacific being vitally interested in the enterprise has been removed. It has been confidently believed that the great aim of the company was to secure such a route to the river and lake, as would enable it to offer the most alluring inducements to the travelling public. It will be remembered that several years ago a charter was obtained to build a bridge at the Falls. Later a line was surveyed on this side of the river and leading to a point in the city that warranted the conclusion that the intentions were to build this bridge between the present car bridge and the Suspension Bridge, and the latter bridge used by the M. C. T. R.

One of the Men Arrested Tells Queen's Evidence—His Confession.

KINGSTON, Nov. 8.—The police court yesterday was crowded with men and women to see the prisoners arrested for complicity in the mail bag robbery, and the report that one of them had turned Queen's evidence and confessed to the affair. The prisoners were W. Cooper, J. McDermott and J. Dinmore. They stood up and were then charged with stealing a post letter on October 30 containing \$1,000. After the examination of the mail bag, the Grand Jurist asked and other railway employes, the court adjourned until the afternoon, when the trial of the robbery was resumed. The evidence of the prisoners, testified to the effect that the station McDermott went to the baggage room and tried to open the window at the back.
