AIR TRANSPORT

POSSIBLE STRIKE BY AIR TRAFFIC CONTROL-LERS—ALLEGED INTERFERENCE IN NEGOTIA-TIONS BY MINISTER OF TRANSPORT

Mr. J. H. Horner (Crowfoot): Mr. Speaker, I ask leave to move the adjournment of the House under Standing Order 26 for the purpose of discussing a specific and important requiring urgent consideration, namely, the crisis stalemate existing today in the negotiations between the Treasury Board and the Canadian Air Traffic Control Association, which has been aggravated by the uncalled for interference by the Minister of Transport by way of public statements with legitimate bargaining processes and by his suggestions, which blatantly disregard public safety, for a makeshift preservation of services in the event of a strike, despite his undertaking made to the Public Service Staff Relations Board on July 31, 1969, to respect a legal strike.

The delays of the Treasury Board and the improper interference of the Minister of Transport so certainly call into question the good faith of the government that settlement by negotiation may well be impossible, and this House should now consider alternative

modes of settlement. I draw this to your attention, Mr. Speaker—

Mr. Speaker: Order, please. The hon member knows that according to the Standing Order he can only give to the House the statement of which he has given notice to the Speaker and which ends with the words "should now consider alternative modes of settlement."

The hon. member for Crowfoot has, as I have intimated, given the notice required by Standing Order 26, and I have had an opportunity to consider all aspects of the proposed motion. While the issue of a possible nationwide strike of air traffic controllers is one of national importance and of immediate interest to all hon. members, I have grave doubts about the advisability of putting the hon. member's motion to the House at this time. After giving the matter my most serious consideration, I have come to the conclusion that the provisions of Standing Order 26 do not allow for the adjournment of the House for the purpose proposed by the hon. member. This does not preclude the hon. member from raising the matter later. My decision is simply that the motion should not be put at this time.
