Football League is a unifying force in Canada, and in light of the proposed 80,000 seat stadium to be built in Montreal, can the right hon. gentleman give an assurance to the Canadian people that in the aftermath of the Olympic games the stadium will not be used as a point of entry for the American football league?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, this is a sort of hypothetical question but in so far as it is based on facts I would point out to the hon. member that the matter of amateur sports and physical fitness comes under the authority of the Minister of National Health and Welfare.

ACTION TO ENSURE TESTING OF DRUGS BY MANUFACTURERS TO DEMONSTRATE SAFETY AND EFFICACY

Mr. P. B. Rynard (Simcoe North): Mr. Speaker, I should like to ask a question of the Minister of National Health and Welfare. He may want to take it as notice or answer by a statement on motions. In view of mounting evidence of the existence of questionable drug manufacturers and questionable prescription products on the market in Canada, and in view of the tendency of provinces to allow pharmacists to substitute on prescriptions without the permission of the physician or the patient, can the minister assure me that the health protection branch will take action to ensure that prior to the initial distribution of a drug product or modification of an existing product every manufacturer will be obligated to perform tests which are appropriate and sufficient to demonstrate the clinical safety and efficacy claimed for the product?
