I have indicated to his Leader that I would look into the problem. Surely that is good enough for now. If he wants to pose the question on November 18, maybe I will have a different answer.

GUIDELINES FOR MINISTERIAL TRIPS OUTSIDE CANADA

Hon. André Ouellet (Papineau): Mr. Speaker, we now know what the Prime Minister forgot yesterday, namely that there are guidelines for authorizations for travel abroad by Ministers. I would like to ask the Deputy Prime Minister, and to refresh his memory, I would like to quote from a letter sent by the Minister of State (Transport) to her colleague at External
