MEASURES PROPOSED BY GOVERNMENT—IMPACT ON FAMILIES

Mr. Jean-Claude Malépart (Montreal-Sainte-Marie): Mr. Speaker, I was shocked by the action taken yesterday by the Minister of National Health and Welfare, who is supposed to defend families with children.

Mr. Speaker, the Government not only wants to reduce the incomes of families with children, it also wants to prevent the Opposition and the Canadian people from telling the truth in this debate. That is why the Minister of social injustice decided to impose closure in the debate on second reading of the Bill to de-index family allowance payments.

Mr. Speaker, it is becoming increasingly clear to me why the Minister is referred to as the Minister of social injustice, a title he richly deserves. It is shameful to see how anxious the Mulroney Government is to gouge the incomes of poor and average Canadians and the reluctance with which it is trying to impose a minimum tax on incomes of rich Canadians who manage not to pay a cent of income tax.

Mr. Speaker, I have here a letter addressed to the Prime Minister by the *Confédération des organismes familiaux du Québec*, from which I would like to quote the following:

Prime Minister, where is the consistency in your approach? You say that you have a great deal of consideration for Canadian families, but you are attacking the meager measures that exist for their benefit. Families are starting to wonder.

Mr. Speaker, from October 7 to 13, for the first time—

Mr. Speaker: Order. I am sorry to interrupt the Hon. Member but his time has expired.

Mr. Jim Manly (Cowichan-Malahat-The Islands): Mr. Speaker, the people of Canada want to extend not only sympathy but also practical help to the people of Mexico following the devastation caused by yesterday's earthquake. The Mexican people and Government face massive problems. Direct victims of the quake need medical treatment. Emergency water and sewage facilities must be provided to prevent epidemic disease. Housing must be provided for people whose homes have been destroyed. There must be emergency distribution of food.

In the name of humanity, the Government of Canada must move quickly to help. Working in co-operation with recognized relief agencies, our Government should announce an immediate program to match, dollar for dollar, all private contributions. Direct Government-to-Government aid should also be given to help repair communication and transportation links, as well as water and sewage lines.

Canada should make the strongest possible representation to the International Monetary Fund to reverse yesterday's badly timed decision that cancelled \$450 million worth of loans to Mexico. I urge the Canadian Government to announce immediate plans for a comprehensive and generous program to help the people of Mexico.
