Mexican Ambassador at Washington

Could Not Survive Surgical

Operation for Appendicitis.

Washington, Dec. 30.—Ambassador Romero

of Mexico died this (Friday) morning

at 4 o'clock, aged 62 years. The deceased

will be taken to Mexico for interment.

On Wednesday last an operation for ap-

pendicitis was performed upon the Amba-

sador, and although the operation was suc-

cessful, the resulting shock proved

greater than he could bear.

Señor Romero probably was the best

known member of the diplomatic corps in

Washington and was for some time his

country's representative in London. He
