lots of fine cheese have continued to sell at 10c., but some small trade-lots, not really fine we should say, have sold at 9c.; common previously offered at 6 to 8c. seem to have been cleared out. Eggs have generally sold as before, at 16c. for cases and 15c. for trade-lots, with enough in; at the close, however, some quoted a cent higher, but we should call this exceptional Small lots of pork have continued exceptional. Small lots of pork have continued in good demand at \$18 to \$18.50. The only old make of bacon in the market has been long-clear, In good demand at \$18 to \$18.50. The only old make of bacon in the market has been long-clear, and it has been rather firmer at 11½ to 11½c. for tons and cases, with still smaller lots at 12c.; a little new Cumberland has sold at 12c.; new rolls have brought 12½c. and bellies 14c., but the total movement in these has been light. New smoked hams have sold usually in small lots at 13 to 13½c., with a few trade-lots at 12½c, and some movement in pickled of heavy-weight at 10¾c. Lard is firmer; with tins sold at 11½c.; tinn is at 11½ to 12c., and pails at 12 to 12½c., with a fairly good demand. Dried apples are in active but obtainable from dealers at 6½ to 7c.; evaporated, however, have continued to sell fairly well at from 9 to 9½c., according to quantity and quality. White beans are almost finished; but a few still obtainable at from \$2.00 to 2.25, the latter for hand-picked, and new expected next month. Liverpool coarse salt has been quiet; cars nominal; trade-lots of not under 100 bags have been offered at 65c., but we do not hear of any sales; small lots have sold very slowly at 70 to 75c. Canadian inactive and unchanged at former prices. former prices.

Wool.—Trade is quiet and prices, apparently, rather easier, with buyers holding off.
