Mr. Diefenbaker: In the interests of securing the widest possible publicity for the denials that have been made would the Prime Minister have both these gentlemen, who were in Viet Nam and who have always had a reputation for responsibility, brought before a committee of parliament—the external affairs committee would be an example-so they may tell their story there and be subject to cross-examination?

Mr. Pearson: I would be very glad indeed, Mr. Speaker, to give consideration to this. I think it is an interesting and important suggestion by my right hon. friend that when the committee on external affairs is meeting it might be a very good thing to have these gentlemen appear before the committee and substantiate their statements.
