MONTREAL-PROTECTION AGAINST BOMB DAMAGE

Hon. J. A. MacLean (Malpeque): Mr. Speaker, I have a question for the Minister of National Defence arising from the answer given yesterday concerning bombings at armouries in Montreal. The minister said that steps had been taken to protect the property of the government of Canada. In view of the second bombing last night which damaged both public and private property, will the minister say whether the government regards the steps taken for the protection of property to be adequate and satisfactory.

Hon. Léo Cadieux (Minister of National Defence): Mr. Speaker, I think it has to be noted first of all that the second bombing, like the first one, actually took place outside the building. I think we can say that the most stringent measures we have taken must have had some effect, because the second bomb was discovered by the security guard who went inside to call the police. Unfortunately the bomb exploded before the police arrived. We are co-operating fully with the Montreal police in order to enforce security as much as possible.

INQUIRY INTO VIOLENCE AT SIR GEORGE WILLIAMS UNIVERSITY
