ADMIRAL ROBERT FALLS

Question No. 1,191—Mr. Cossitt:

Is the government renting a residence in Brussels for Admiral Robert Falls, Canada's NATO representative and, if so, what is the name of the owner, the address of the residence and any other particulars known to the government?

Mr. Louis Duclos (Parliamentary Secretary to Secretary of State for External Affairs): The government is renting a residence in Brussels for Admiral Robert Falls, the chairman of the military committee of NATO. The house is located at number 8 Domaine de Fuji—1970 Welembek, Brussels and is owned by Dr. and Mrs. Buisseret. The annual rental is 2,100,000 Belgian francs which at the rate of exchange at the time of signature of the lease was equivalent to \$81,816.00 Canadian. The lease was effective March 15, 1980 for a nine year and five month period but can be terminated at no cost after each triennium.
