INVESTIGATION OF LEADER OF THE OPPOSITION—ACTIVITIES
OF OFFICIALS—PRIME MINISTER'S KNOWLEDGE

Hon. Flora MacDonald (Kingston and the Islands): Mr. Speaker, in the absence of the Prime Minister my question is directed to the Acting Prime Minister. It concerns the daily revelations of the investigations by the Prime Minister's Office into the personal affairs of the Leader of the Opposition as a private individual, the latest being into his private home. I have been associated with the offices of two Conservative Prime Ministers and neither of these gentlemen would have engaged, or ever did engage in such disgraceful tactics—

Miss MacDonald: —and neither would the Prime Minister's predecessors, the late Right Hon. Mr. St. Laurent, and the late Right Hon. Mr. Pearson.

My questions to the Acting Prime Minister are: did the Prime Minister know that his principal secretary and others associated with his office were engaged in this kind of nefarious practice, and did the Prime Minister condone those activities?

An Hon. Member: Here he is now.

Mr. Chrétien: Mr. Speaker, I was about to say that the Prime Minister was on his way, but he is already here.

Some Hon. Members: Hear, hear!

Miss MacDonald: Mr. Speaker, I think that under the circumstances I should repeat the question.

Mr. Speaker, the Prime Minister having arrived, I will repeat my question. It concerns the daily revelations of the investigation by the Prime Minister's Office into the personal affairs of the Leader of the Opposition as a private citizen, the latest concerning his private home. ing them as nefarious practices. I know of no such nefarious practices. I know of no investigation into private affairs. I have begun to read the public record in the last hour, and I have seen the exchange which took place yesterday in the House, and have read some of the clippings. It seems to me it has been established quite clearly by the Deputy Prime Minister that there has been no investigation into private affairs. There has been the use of a clipping service. There has been access made to public records. Everything that has been done has been made public.

I understand that my personal secretary has offered access to the media, which have spent quite a bit of time looking at all of our clipping services and other files. There is nothing personal in them. It is all matters culled from newspapers on the public record.

The Hon. Member suggests there were no such practices in the times of previous Prime Ministers. I understand that there is such a practice occurring in the office of the Leader of the Opposition, that he has a couple of boxes on myself that he will not show to the press. Perhaps the hon. lady should dissociate herself from her present Leader since he is so far below the standards established by the other gentlemen that she mentions.
