a letter that a special assistant in the Prime Minister's Office sent to my chief of staff which states, "Please find enclosed copy of correspondence—" for my attention. "The family wish to reside here. I thank you for your kind assistance".

If that is the type of representation that is bothering the Member, it is the right of every Member of Parliament to divert pieces of correspondence, as other Members have done, and some 7,000 have been received in my office in the last 13 months.

Some Hon. Members: Hear, hear!

## JUSTIFICATION FOR DECISION

Mr. Sergio Marchi (York West): As a result of government orders, the Ottawa immigration counsellor wrote in her notes, "I thought we were employed by the Treasury Board and not a political Party"—and the Justice Minister laughs.

What possible reasons justify such a flagrant disregard of the process and of our Immigration Act?

The Leader of the Opposition perhaps remembers the time he called my office and wished some attention.

Mr. Mazankowski: Shame on you, John!

An Hon. Member: No, don't resign. Stay right there.

Mr. Speaker: I am sure that the Hon. Minister will answer the question as briefly as possible.

Mr. Weiner: This case is no different from hundreds of others that are handled in a routine manner.

Officers may consider sympathetically the situation of long-term employment authorization holders who request processing of their application for permanent residence from within Canada.

## SOUTH AFRICA—ISSUE OF VIOLENCE

In late August the Minister told Oliver Tambo, I understand, that the ANC should abandon violent struggle in return for Canadian support.

What is the black majority in South Africa to believe?
