## PRIVILEGE

## ALLEGED UNPARLIAMENTARY CONDUCT

**Mr. Guilbault (Saint-Jacques):** Mr. Speaker, when the Hon. Leader of the New Democratic Party (Mr. Broadbent) started discussing with the other side—as a matter of fact, the point was raised by the Deputy Prime Minister (Mr. Mazankowski) about the word “lie” used as recorded in *Hansard*—I was about to rise on a question of privilege because of the words that were pronounced by the Prime Minister (Mr. Mulroney) yesterday when he said:

I know that my hon. friends in the Liberal and the New Democratic Parties are opposed to the interests of western Canada. That becomes clearer every day.

Your Honour said earlier that you wanted to state—I am not sure what Your Honour meant. Are you staying the decision? Are you delaying the decision? You will make a decision on this later, obviously, and if you do this, will you be hearing further representations on the case?

**Mr. Speaker:** No, I am sorry—

**Mr. Guilbault (Saint-Jacques):** This is why I would like to know what Your Honour meant, because we are highly interested—

**Some Hon. Members:** Sit down!

**Mr. Speaker:** I would ask Hon. Members to extend the courtesy in this place that is appropriate. No Hon. Member needs to be told to sit down, except perhaps when the Chair has to do it. The Hon. Member for Saint-Jacques (Mr. Guilbault) has asked a question. The Hon. Deputy Prime Minister (Mr. Mazankowski) has raised a point of privilege. It has been partly responded to by the Hon. Leader of the New Democratic Party (Mr. Broadbent). I felt it was in the interests of this place that that matter be adjourned for an hour and that is what I am doing. I say “adjourned”, not closed off, and in 45 minutes now, because that was 15 minutes ago, I will hear the Hon. Leader of the New Democratic Party further. But, I have adjourned that matter for 45 minutes for reasons which I think Hon. Members can well understand. It may be that the Hon. Member for Saint-Jacques would wish to make an intervention at that time.

## REQUEST FOR TABLING OF QUOTED DOCUMENT

**Ms. Sheila Copps (Hamilton East):** Mr. Speaker, I rise on a point of order. I believe the Deputy Prime Minister (Mr. Mazankowski) did quote directly from documents from the Department of Regional Industrial Expansion and I would ask that he now table the full document pursuant to Standing Order 327.
