Moves to go on with Bill No 36. Regrets the minister does no agree—12191. The Bill has not been reached since it came from the Senate—12192.

Reference made to the matter—Mr. Geo. Taylor—1429.

Lemieux, Hon. Rodolphe (Postmaster General)—1436.

Will discuss the matter with Taylor and Armstrong, Chief Superintendent of Mail Service, and then go to the Commission—1436. If Morin and Taylor will come to him after Tuesday will do his best to meet their wishes—1437.

Morin, J. B. (Dorchester)-1436.
