#### WINNIPEG—DISPOSITION OF AIR CANADA OVERHAUL BASE

##### Motion No. 227—**Mr. Orlikow:**

That an Order of the House do issue for a copy of the Contract or Agreement between Air Canada and Northwest Industries, regarding disposition of the Air Canada Overhaul Base in Winnipeg, including the contract showing purchase price, agreement as to future employment of present Air Canada employees, etc.

**Hon. Donald C. Jamieson (Minister of Transport):** Mr. Speaker, Air Canada reports to me that the agreements and contracts between Air Canada and CAE Aircraft Limited are considered to be proprietary documents between two commercial corporations and therefore should not be released.

In answer to the motion I would be pleased to file a short listing provided by Air Canada containing a summary of the provisions for the employees, both permanent and temporary, together with other pertinent information, if it is agreeable to the hon. member for Winnipeg North.

**Mr. David Orlikow (Winnipeg North):** Mr. Speaker, I will accept that for now but I give notice that I will introduce a similar motion early in the next session.

**Mr. Speaker:** Subject to the conditions and reservations expressed by the minister is it agreed that motion No. 227 be deemed to have been adopted?

#### RAINBOW TROUT FARMING

##### Motion No. 228—**Mr. Orlikow:**

**Mr. E. F. Whelan (Parliamentary Secretary to Minister of Fisheries and Forestry):** Mr. Speaker, notes prepared for the use of the Minister of Fisheries and Forestry when announcing the construction of the new Freshwater Research Institute in Winnipeg on June 23, 1969, referred to "other possible methods of commercial trout rearing" which "justify experimentation." To date no cost-benefit analysis of these alternative fisheries has been completed. Since there is no conclusive study or final report available on these "other possible methods of commercial trout rearing", the hon. member may wish to withdraw his motion.
