2. Bill further to amend "The Pilotage Act, 1873," and the other Acts therein mentioned (Mr. McLelan); Ordered; Presented, 237. Read a second time, 262. Committed; Progress reported, 363. 2. House in Committee to provide for increasing the number of Constables in the North-West Mounted Police Force; Resolution reported; Agreed to, 213. Referred to Committee of the Whole on the Bill respecting the North-West Mounted Police Force, 274. See *supra*, 1.

House in Committee respecting Tonnage duty on vessels entering the Ports of Montreal and Quebec, for the purposes of the Act respecting Harbor and River Police of Canada; Resolution reported: Agreed to, 210. 4. Bill intituled: "An Act respecting Harbor and River Police of Canada;" From the Senate, 167. Read, 168. Read a second time; Committed; Resolution referred; (See *supra*, 3); Proceedings interrupted by Private Bills, 425. Committee resumed; Bill amended (Title amended by leaving out word "Canada," and inserting "the Province of Quebec"); Considered; Agreed to; Passed, 426. Senate agrees, 439. R.A., 518.
